BERNALES CONSTRUCTION & SUPPLIES** at Taal treet, De Mesa Compound, Brgy. Gulang-Gulang, Lucena City called the "**CONTRACTOR**".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Work - Under **Contract No.4AQ-LPM-20-007**- Construction of Canal and Structures @ Main Canal - 2, Sta. 3+190.00 to Sta. 4+201.30 Package 4 of **MACALELON SMALL RESERVOIR IRRIGATION PROJECT** in Macalelon, Quezon hereinafter called " The Works", and the ENTITY has accepted the Calculated Bid of the CONTRACTOR for the execution and completion of the Works at the stated unit bid prices shown in the attached Bill of Quantities, or a Total Contract Price of **EIGHT MILLION NINE HUNDRED NINETY FOUR THOUSAND EIGHT HUNDRED TWENTY THREE PESOS & 81/100 (Php8,994,823.81)**


