**CONTRACT AGREEMENT**

THIS **CONTRACT AGREEMENT**, made this 23<sup>rd</sup> day of April 2021, between **GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES, NATIONAL IRRIGATION ADMINISTRATION**, REGION IV-A, PILA, LAGUNA; hereinafter called the "**ENTITY**", and **CHARLMELDAY CONSTRUCTION SUPPLY AND SERVICES** at No. 394 Grand Riviera Subdivision, Brgy. Bulilan Sur, Pila, Laguna, hereinafter called the "**CONTRACTOR**".

WHEREAS, the **ENTITY** is desirous that the **CONTRACTOR** execute the Work - Under **Project Identification No. 4ARO-SRN-21-005B** Improvement of Service Road of **SAN CRISTOBAL RIVER IRRIGATION SYSTEM** Package 2 in **Calamba City, Laguna** hereinafter called "The Works", and the **ENTITY** has accepted the the Bid for **TWO MILLION EIGHT HUNDRED NINETY SIX THOUSAND EIGHT HUNDRED SEVENTY FIVE PESOS & 33/100 PHP 2,896,875.33**

by the **CONTRACTOR** for the execution and completion of such Works and the remedying of any defects therein.


**NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:**

1. In this **AGREEMENT**, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act. No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz:
  - a. Philippine Bidding Documents (PBDs);
    - i. Drawings/Plans;
    - ii. Specifications;
    - iii. Bill of Quantities;
    - iv. General and Special Conditions of Contract;
    - v. Supplemental or Bid Bulletins, if any;
  - b. Winning bidder's bid including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;


Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and;
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
