THIS CONTRACT AGREEMENT, made this 25th day of July, 2016, GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES, NATIONAL IRRIGATION ADMINISTRATION, REGION IV-A, PILA, LAGUNA; hereinafter called the "ENTITY", and R'CEL GENERAL AND GENERAL MERCHANDISE at No. 1736 Bonifacio St., Sta. Cruz, Laguna called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Work - Under Contract No. ARJONA-6M-RRECIS-CY16 - Construction of Canal System of ARJONA COMMUNAL IRRIGATION SYSTEM, Liliw, Laguna hereinafter called "The Works", and the ENTITY has accepted the Calculated Bid of the CONTRACTOR for the execution and completion of the Works at the stated unit bid prices shown in the attached Bill of Quantities, or a Total Contract Price of FIVE MILLION FIVE HUNDRED TWENTY ONE THOUSAND ONE HUNDRED SIXTY SIX PESOS & 07/100 (Php5,521,166.07)




