
THIS CONTRACT AGREEMENT, made this 6<sup>th</sup> day of May, 2016, GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES, NATIONAL IRRIGATION ADMINISTRATION, REGION IV-A, PILA, LAGUNA; hereinafter called the "ENTITY", and **D.M. CATIGNAS ENTERPRISES** at A. Mabini Cor Zalamilla Sts., Brgy. Sampaloc, Pagsanjan, Laguna called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Work - Under Contract No. **SIPSIPIN-0.68M-RRECIS-CY16** - Construction of Concrete Canal Lining of **SIPSIPIN COMMUNAL IRRIGATION SYSTEM**, Jala-Jala, Rizal hereinafter called "The Works", and the ENTITY has accepted the Calculated Bid of the CONTRACTOR for the execution and completion of the Works at the stated unit bid prices shown in the attached Bill of Quantities, or a Total Contract Price of **SIX HUNDRED TWENTY SEVEN THOUSAND EIGHT HUNDRED FIFTEEN PESOS & 95/100 (Php627,815.95)**.




