THIS CONTRACT AGREEMENT, made this 22nd day of September, 2016, GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES, NATIONAL IRRIGATION ADMINISTRATION, REGION IV-A, PILA, LAGUNA; hereinafter called the "ENTITY", and ERCOBAL CONSTRUCTION CORP. at No. 62 Canlogan CCL, Morong, Rizal called the "CONTRACTOR".


WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Work - Under Contract No. KAY SAKAT-4.6M-RRECIS-CY16 - Proposed Check Structure, Protection Works & Canal Structures for KAY SAKAT COMMUNAL IRRIGATION SYSTEM in Antipolo City, Rizal hereinafter called "The Works", and the ENTITY has accepted the Calculated Bid of the CONTRACTOR for the execution and completion of the Works at the stated unit bid prices shown in the attached Bill of Quantities, or a Total Contract Price of FOUR MILLION TWO HUNDRED FOUR THOUSAND THREE HUNDRED THIRTY ONE PESOS AND 32/100 (Php4,204,331.32)


