



Invitation to Bid for *Drilling Works and Construction of Solar Pump Facilities of JANOPOL Small Irrigation Project*

1. The **NIA Cavite-Batangas Irrigation Management Office**, through the **GAA FY 2021** intends to apply the sum of **Five Million Six Hundred Eighty-Six Thousand Four Hundred Sixty-Two and 87/100 Pesos (Php 5,686,462.87)** being the Approved Budget for the Contract (ABC) to payments under the Contract No. **4AB-SIP-21-023 for the Drilling Works and Construction of Solar Pump Facilities of JANOPOL Small Irrigation Project in Tanauan City, Batangas**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **NIA Cavite-Batangas Irrigation Management Office** now invites bids for the above Procurement Project. Completion of the Works is required **one hundred eighty (180) days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from **NIA Cavite-Batangas Irrigation Management Office** and inspect the Bidding Documents at **NIA Cavite-Batangas Irrigation Management Office Ibayo Silangan, Naic, Cavite from 8:00AM to 5:00 PM, Monday to Friday**.
5. Onetime group site inspection is schedule on **04 December, 2020, Friday, 9:00 A.M.** The meeting place will be at **NIA Cavite-Batangas Satellite Office, Batangas City, Batangas at 9:00 A.M.** The inspection is necessary in coming up of a responsive bid.
6. A complete set of Bidding Documents may be acquired by interested bidders on **09 December 2020, Wednesday**, from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Ten Thousand Pesos (Php 10,000)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, by facsimile, or through electronic means.
7. The **NIA Cavite-Batangas Irrigation Management Office** will hold a Pre-Bid Conference¹ on **09 December 2020, Wednesday, 10:01 A.M. at NIA Cavite-Batangas Irrigation Management Office Ibayo Silangan, Naic, Cavite** which shall be open to prospective bidders.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 16**.




