### INVITATION TO BID

1. The NIA Cavite-Batangas Irrigation Management Office, through **GAA CY 2019** intends to apply the sum of **Three Million Three Hundred Eight Thousand One Hundred Forty and 78/100 Pesos (P3,308,140.78)** being the Approved Budget for the Contract (ABC) to payments under the **Contract No. 4AC-EEN-19-015**. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.
2. The NIA Cavite-Batangas Irrigation Management Office now invites bids for the **Construction of Canal Lining of Kay-Akle River Irrigation System (Cantaricio)**. The Project is located at **Maragondon, Cavite**. Completion of the Works is required within **90 calendar days**. Minimum equipment requirement/s:  
**One (1) unit One-Bagger Concrete Mixer**
3. Bidders should have a completed single similar contract with value of at least 50% of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
4. Onetime group site inspection is schedule on **January 2, 2019, 2:00 PM**. The meeting place will be at **NIA Cavite-Batangas Irrigation Management Office, Naic, Cavite** at **2:00 PM**. The inspection is necessary in coming up of a responsive bid.
5. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (IRR 9184), otherwise known as the "Government Procurement Reform Act".
6. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
7. Interested bidders may obtain further information on the Bidding Documents and other essential requirements to the **Secretariat, Bids and Awards Committee, NIA Cavite-Batangas Irrigation Management Office Ibayo Silangan, Naic, Cavite** from **8:00AM to 5:00 PM, Monday to Friday**.
8. A complete set of Bidding Documents may be purchased by interested bidders upon presentation of **Letter of Intent (LOI), Philgeps Registration, renewed PCAB License with "Small B" in Irrigation and Flood Control-IAC Certificate of Registration, renewed & valid Mayor's / Business Permit, Tax Clearance, DTI Registration Certificate or SEC Registration Certificate** and upon payment at the NIA-Cavite-Batangas Irrigation Management Office Cashier of non-refundable fee in the amount of **Five Thousand Pesos (Php 5,000.00)**.
9. The NIA Cavite-Batangas Irrigation Management Office will hold a **Pre-Bid Conference on 03 January 2019, Thursday, 2:00 PM** at the **NIA-CBIMO Conference Room Ibayo Silangan, Naic, Cavite** the will be open only to all interested parties who have purchased Bidding Documents.


