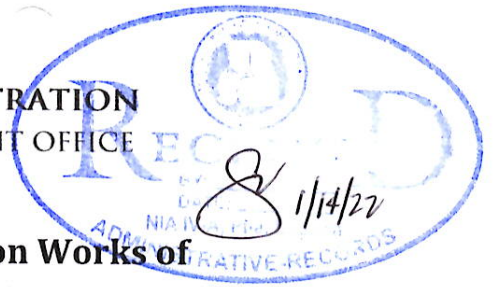

**Invitation to Bid for Proposed Protection Works of  
Sta. Maria River Irrigation System**  
Sta. Maria, Laguna

1. The NIA LRIMO Office, through the *GAA CY 2022* intends to apply the sum of **Six Million Nine Hundred Thirty-Seven Thousand Four Hundred Twenty-Three Pesos and 90/100 (₱6,937,423.90)** being the Approved Budget for the Contract (ABC) to payment under the contract for **Proposed Protection Works of Sta. Maria River Irrigation System** with contract no. **4AL-CCAW-22-010**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The NIA LRIMO now invites bids for the above Procurement Project. Completion of the Works is required within **150 calendar days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders). *Minimum equipment requirement/s:*

**2 (Two) Units 1-Bagger Concrete Mixer**  
**1 (One) Unit Dozer (200HP)**  
**1 (One) Unit Backhoe (0.70-1.0 cu.m.)**  
**1 (One) Unit Self Propelled Compactor, Vibratory Drum (1.2 tons)**  
**1 (One) Unit 4" dia. Centrifugal Pump (10HP)**

3. Onetime group site inspection is scheduled on **January 19, 2022, Wednesday, 9:00 AM**. The meeting place will be at **NIA LRIMO Office, Pila, Laguna** at **8:30 AM**. Site inspection is necessary in coming up of a responsive bid.
4. Bidding will be conducted through open competitive bidding procedures using nondiscretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
5. Interested bidders may obtain further information from the **Secretariat, Bids and Awards Committee, NIA LRIMO Office, Pila, Laguna** and inspect the Bidding Documents at the address given below from **8:00 AM to 5:00 PM, Monday to Friday**.
6. A complete set of Bidding Documents may be acquired by interested bidders on **January 21, 2022** from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB upon presentation of **Letter of Intent (LOI), PhilGEPS Registration, renewed PCAB License with "Small B" in Irrigation and Flood Control-IAC Certificate of Registration, renewed & valid Mayor's/Business Permit, Tax Clearance, DTI Registration Certificate or SEC Registration Certificate and Certificate of Site Inspection issued by the Laguna-Rizal IMO Manager**, at the NIA LRIMO Cashier of a non-refundable fee in the amount of **Five Thousand Pesos (₱ 10,000.00)** The Procuring Entity shall allow the bidder to present its proof of payment for the fees through facsimile.
7. The NIA LRIMO will hold a **Pre-Bid Conference on January 21, 2022, Friday, 10:00 AM** at the **NIA LRIMO Conference Room, Pila, Laguna** which shall be open to prospective bidders.
8. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below **on or before 01:40 PM on February 03, 2022, Thursday**. Late bids shall not be accepted.
9. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the ITB Clause 16.
