INVITATION TO BID

1. The NIA-Quezon Irrigation Management Office through **GAA CY 2019** intends to apply the sum of **Six Million Six Hundred Sixteen Thousand Six Hundred Seventy-Eight Pesos and 9/100 (P 6,616,678.09)** being the Approved Budget for the Contract (ABC) to payments under Contract No. **4AQ-RPC-19-007**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The NIA- Quezon Irrigation Management Office now invites bids for the **Construction of River Protection Works of Villa Victoria Communal Irrigation System**. The project is located at Alabat, Quezon. Minimum equipment requirement/s:
Two (2) units – One-bagger Concrete Mixer
One (1) unit – 4” dia. Centrifugal Pump, 7HP

Completion of the Works is required within **150 calendar days**.
3. Bidders should have a completed single similar contract with a value of at least 50% of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II, Instruction to Bidders.
4. One time group site inspection is scheduled on **December 3, 2018, 8:00 AM**. The meeting place will be at **Atimonan Port, Atimonan, Quezon** at **7:00 AM**. Site inspection is necessary in coming up of a responsive bid.
5. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Revised Implementing Rules and Regulations of Republic Act No. 9184 (IRR 9184) otherwise known as the “Government Procurement Reform Act”.
6. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
7. Interested bidders may obtain further information on the Bidding Documents and other essential requirements to the **Secretariat, Bids and Awards Committee, NIA Quezon Irrigation Management Office, Lucena City, Quezon** from **8:00 AM to 5:00 PM, Monday to Friday**.
8. A complete set of Bidding Documents may be purchased by interested bidders upon presentation of **Letter of Intent (LOI), PhilGEPS Registration, renewed PCAB License with “Small B” in Irrigation and Flood Control-IAC Certificate of Registration, renewed and valid Mayor’s / Business Permit, Tax Clearance, DTI Registration Certificate** or **SEC Registration Certificate** and **Certificate of Site Inspection issued by the Quezon IMO Manager** and upon payment at the NIA-Quezon IMO Cashier of a non-refundable fee in the amount of **Ten Thousand Pesos (P 10,000.00)**.

Opening of bids will be held at the same day at ***11:01 AM*** in the presence of invited observers, bidders, or its duly authorized representative who choose to attend at the ***NIA Quezon IMO Conference Room, Lucena City, Quezon***. Late bids shall not be accepted.
11. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the ITB Clause 18.

The National Irrigation Administration Quezon Irrigation Management Office (NIA) reserves the right to accept or reject any and all bids, to annul the bidding process and to reject all bids at any time prior to contract award, without incurring any liability to the affected bidder or bidders; and not to award the contract due to the situations cited in Section 41 of the revised IRR of RA 9184.
