INVITATION TO BID

1. The NIA LRIMO Office through *GAA CY 2019* intends to apply the sum of **One Million Three Hundred and Sixty Five Thousand Pesos (₱ 1,365,000.00)** being the Approved Budget for the Contract (ABC) to payments under Contract No. **4AR-EGP-19-017**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The NIA LRIMO now invites bids for the **Procurement and Delivery of 13 (Thirteen) Units of 4" Ø Centrifugal Pump 7HP (Diesel Engine Driven) with Complete Accessories of Jala-jala Pump Irrigation Project**. The project is located in **Jala-jala, Rizal**. Completion of the Works is required within **60 calendar days**.
3. Bidders should have a completed single similar contract with a value of at least 50% of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II, Instruction to Bidders.
4. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Revised Implementing Rules and Regulations of Republic Act No. 9184 (IRR9184) otherwise known as the "Government Procurement Reform Act".
5. Bidding is restricted to Filipino citizens/sole proprietorship, partnerships, or organizations with at least seventy-five (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
6. Interested bidders may obtain further information on the Bidding Documents and other essential requirements to the **Secretariat, Bids and Awards Committee, NIA LRIMO Office, Pila, Laguna from 8:00 AM to 5:00 PM, Monday to Friday**.
7. A complete set of Bidding Documents may be purchased by interested bidders upon presentation of **Letter of Intent (LOI), PhilGEPS Registration, renewed & valid Mayor's/Business Permit, Tax Clearance, DTI Registration Certificate or SEC Registration Certificate and Certificate of Site Inspection issued by the Laguna-Rizal IMO Manager** and upon payment at the NIA LRIMO Cashier of a non-refundable fee in the amount of **Five Thousand Pesos (₱ 5,000.00)**.
8. The NIA LRIMO will hold a **Pre-Bid Conference on January 15, 2019, ~~Friday~~ ^{Tuesday} 10:00 AM** at the **NIA LRIMO Conference Room, Pila, Laguna** that will be open to all interested parties who have purchased Bidding Documents.

9. Bids must be delivered *on or before 11:40 AM on January 29, 2019*. Opening of bids will be held at the same day at *11:41 AM* in the presence of invited observers, bidders or its duly authorized representative who choose to attend at the *NIA LRIMO Conference Room, Pila, Laguna*. Late bids shall not be accepted.
10. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the ITB Clause 18.
11. The National Irrigation Administration Laguna-Rizal Irrigation Management Office (LRIMO) reserves the right to accept or reject any and all Bids, to annul the bidding process and to reject all bids at any time prior to contract award, without incurring any liability to the affected bidder or bidders; and no to award the contract due to the situations cited in Section 41 of the revised IRR of RA 9184.
