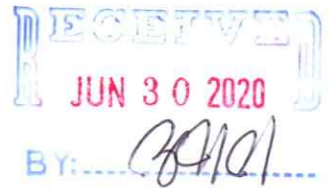

INVITATION TO BID

1. The NIA Region IV-A Office through **GAA CY 2020** intends to apply the sum of **Ten Million Nine Hundred Eighty-One Thousand Nine Hundred Eighty-Nine Pesos and 98/100 (P 10,981,989.98)** being the Approved Budget for the Contract (ABC) to payments under Contract No. **4AQ-LPA-20-019C**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The NIA Region IV-A now invites bids for the **Construction of Canal System, Package 3 of Agos River Irrigation System**. The project is located at Infanta, Quezon. Minimum equipment/s:
Two (2) units One-Bagger Concrete Mixer
Completion of the Works is required within **180 calendar days**.
3. Bidders should have a completed single similar contract with a value of at least 50% of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II, Instructions to Bidders.
4. Bidders shall be deemed to have inspected the site and shall be sole responsible to determine and to satisfy itself by such means as it considers necessary or desirable as to all matters pertaining to this project.
5. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Revised Implementing Rules and Regulations of Republic Act No. 9184 (IRR 9184) otherwise known as the "Government Procurement Reform Act".
6. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
7. Interested bidders may obtain further information on the Bidding Documents and other essential requirements to the **Secretariat, Bids and Awards Committee, NIA Region IV-A Office, Pila, Laguna from 8:00 AM to 5:00 PM, Monday to Friday**.
8. A complete set of Bidding Documents may be purchased by interested bidders upon presentation of **Letter of Intent (LOI), PhilGEPS Registration, renewed PCAB License with "Small B" in Irrigation and Flood Control-IAC Certificate of Registration, renewed & valid Mayor's / Business Permit, Tax Clearance, DTI Registration Certificate or SEC Registration Certificate** and upon payment at the NIA-R4A Cashier of a non-refundable fee in the amount of **Ten Thousand Pesos (P 10,000.00)**.

9. The NIA Region 4A will hold a **Pre-Bid Conference on July 7, 2020, Tuesday, 2:00 PM** at the **NIA Region 4A Conference Room, 2nd Floor NIA Regional Office No. 4A CALABARZON, Pila, Laguna** that will be open only to all interested parties who have purchased Bidding Documents.
10. Bids must be delivered **on or before 3:00 PM, July 21, 2020**. Opening of bids will be held at the same day at **3:01 PM** in the presence of invited observers, bidders or its duly authorized representative who choose to attend at the **NIA Region 4A Conference Room, Pila, Laguna**. Late bids shall not be accepted.
11. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the ITB Clause 18.
12. The National Irrigation Administration Region IV-A (NIA) reserves the right to accept or reject any and all Bids, to annul the bidding process and to reject all bids at any time prior to contract award, without incurring any liability to the affected bidder or bidders; and not to award the contract due to the situations cited in Section 41 of the revised IRR of RA 9184.
