## Invitation to Bid for AGOS River Irrigation System (RIS)

1. The **NATIONAL IRRIGATION ADMINISTRATION REGION IV-A (CALABARZON)**, through the **GAA 2021** intends to apply the sum of **Twenty-Nine Million Five Hundred Three Thousand Six Hundred Forty-Eight Pesos and 26/100 (Php 29,503,648.26)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Construction of Diversion Works (Double Barrel Cut & Cover @ Sta. 0+000.00 to Sta. 0+600.00 and Temporary Facilities)** of **Agos River Irrigation System (RIS) Package 2** located in **Infanta, Quezon** with Project Identification No. **4ARO-LPA-21-026B**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **NATIONAL IRRIGATION ADMINISTRATION REGION IV-A (CALABARZON)** now invites bids for the above Procurement Project. Completion of the Works is required **180 calendar days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. **Certificate of Site Inspection** will be submitted prior to purchasing of bidding documents. As stated in the bidding documents that **“Bidders, by the act of submitting its bid shall be deemed to have inspected the site, determined the general characteristics of the contracted works and the conditions for this project”**. Site inspection is necessary in coming up of a responsive bid.
5. Interested bidders may obtain further information from **NATIONAL IRRIGATION ADMINISTRATION REGION IV-A (CALABARZON)** and inspect the Bidding Documents at the address given below from **8:00 A.M** up to **5:00 P.M.**
6. A complete set of Bidding Documents may be acquired by interested bidders on **May 14, 2021** from given address and websites below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Twenty-Five Thousand Pesos (Php 25,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees presented in person, by facsimile, or through electronic means.
7. The **NATIONAL IRRIGATION ADMINISTRATION REGION IV-A (CALABARZON)** will hold a Pre-Bid Conference on **Tuesday, May 25, 2021, 2:00 PM** at NIA Region IV-A Conference Room, 2<sup>nd</sup> Floor NIA Region IV-A (CALABARZON), Pila, Laguna which shall be open to prospective bidders.
8. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below **on or before Tuesday, June 8, 2021, 2:30 PM**. Late bids shall not be accepted.
9. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 15.
