BERNALES CONSTRUCTION & SUPPLIES** at Taal St., De Mesa Compound, Brgy. Gulang-Gulang, Lucena City called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Work - Under **Contract No. LAGULUAN-.81M-RRECIS-CY16** -Construction of Canal System of **LAGULUAN COMMUNAL IRRIGATION SYSTEM in Lian, Batangas** hereinafter called the "The Works", and the ENTITY has accepted the Calculated Bid of the CONTRACTOR for the execution and completion of the Works at the stated unit bid prices shown in the attached Bill of Quantities, or a Total Contract Price of **ONE MILLION SIX HUNDRED NINETY THOUSAND EIGHT HUNDRED FIFTY EIGHT PESOS & 65/100 (Php1,690,858.65)**






