BERNALES CONSTRUCTION & SUPPLIES** at Taal St., De Mesa Compound, Brgy. Gulang-Gulang, Lucena City City called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Work - Under **Contract No. TIMBUGAN-3.9M-RRECIS-CY16** - Construction of Diversion Works of **TIMBUGAN COMMUNAL IRRIGATION SYSTEM**, Rosario, Batangas hereinafter called "The Works", and the ENTITY has accepted the Calculated Bid of the CONTRACTOR for the execution and completion of the Works at the stated unit bid prices shown in the attached Bill of Quantities, or a Total Contract Price of **THREE MILLION SIX HUNDRED TWENTY THREE THOUSAND EIGHT HUNDRED SIXTEEN PESOS & 29/100 (Php3,623,816.29)**




