



Invitation to Bid for the Construction of Protection Works of upstream portion of the Dam and Construction of Protection Works of Canal Structure of San Guillermo Communal Irrigation System

1. The ***NIA Cavite-Batangas Irrigation Management Office***, through the ***GAA FY 2023*** intends to apply the sum of ***Seven Million Five Hundred Forty-Four Thousand Seven Hundred Sixty-One and 78/100 Pesos (Php 7,544,761.78)*** being the Approved Budget for the Contract (ABC) to payments under the Contract No. ***4AB-RRC-23-043 for the Construction of Protection Works of upstream portion of the Dam and Construction of Protection Works of Canal Structure of San Guillermo Communal Irrigation System in Lipa City, Batangas***. Bids received in excess of the ABC shall be rejected at bid opening.
2. The ***NIA Cavite-Batangas Irrigation Management Office*** now invites bids for the above Procurement Project. Completion of the Works is required ***one hundred eighty calendar (180) days***. Automatically Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from ***NIA Cavite-Batangas Irrigation Management Office*** and inspect the Bidding Documents at ***NIA Cavite-Batangas Irrigation Management Office Ibayo Silangan, Naic, Cavite from 8:00AM to 5:00 PM, Monday to Friday***.
5. Onetime group site inspection is schedule on ***20 July, 2023, Thursday, 9:00 A.M.*** The meeting place will be at ***NIA Batangas Satellite Office in Batangas City, Batangas at 9:00 A.M.*** The inspection is necessary in coming up of a responsive bid.
6. A complete set of Bidding Documents may be acquired by interested bidders on ***21 July 2023, Friday***, from given address and website/s below *and* upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of ***Ten Thousand Pesos (Php 10,000)***. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, by facsimile, or through electronic means.
7. The ***NIA Cavite-Batangas Irrigation Management Office*** will hold a Pre-Bid Conference¹ on ***21 July 2023, Friday, 10:00 A.M. at NIA Cavite-Batangas Irrigation Management Office Ibayo Silangan, Naic, Cavite*** which shall be open to prospective bidders.

9. Bid opening shall be on **03 August 2023, Thursday 11:01 A.M. at NIA Cavite-Batangas Irrigation Management Office Ibayo Silangan, Naic, Cavite**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity. Late bids shall not be accepted.

The **NIA Cavite-Batangas Irrigation Management Office** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
