



## ***Invitation to Bid for the Drilling Works and Construction of Solar Pump Facilities of Bagong Pook Solar Pump Irrigation Project***

1. The ***NIA Cavite-Batangas Irrigation Management Office***, through the ***GAA FY 2023*** intends to apply the sum of ***Thirteen Million Three Hundred Seventy-Three Thousand Eight Hundred Eighty-Six and 14/100 Pesos (Php 13,373,886.14)*** being the Approved Budget for the Contract (ABC) to payments under the Contract No. ***4AC-CRP-23-014 for the Drilling Works and Construction of Solar Pump Facilities of Bagong Pook Solar Pump Irrigation Project in Magallanes, Cavite***. Bids received in excess of the ABC shall be rejected at bid opening.
2. The ***NIA Cavite-Batangas Irrigation Management Office*** now invites bids for the above Procurement Project. Completion of the Works is required ***three hundred calendar days (300) days***. Automatically Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary ***“pass/fail”*** criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from ***NIA Cavite-Batangas Irrigation Management Office*** and inspect the Bidding Documents at ***NIA Cavite-Batangas Irrigation Management Office Ibayo Silangan, Naic, Cavite from 8:00AM to 5:00 PM, Monday to Friday***.
5. Onetime group site inspection is schedule on ***10 February, 2023, Friday, 9:00 A.M.*** The meeting place will be at ***NIA Cavite Batangas Irrigation Management Office in Ibayo Silangan, Naic, Cavite at 9:00 A.M*** The inspection is necessary in coming up of a responsive bid.
6. A complete set of Bidding Documents may be acquired by interested bidders on ***15 February 2023, Wednesday***, from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of ***Twenty-Five Thousand Pesos (Php 25,000)***. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, by facsimile, or through electronic means.
7. The ***NIA Cavite-Batangas Irrigation Management Office*** will hold a Pre-Bid Conference<sup>1</sup> on ***15 February 2023, Wednesday 11:30 A.M. at NIA Cavite-Batangas Irrigation Management Office Ibayo Silangan, Naic, Cavite*** which shall be open to prospective bidders.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ***ITB Clause 16***.
