THIS CONTRACT AGREEMENT, made this _____ day of _____, _____, GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES, **NATIONAL IRRIGATION ADMINISTRATION, CAVITE-BATANGAS IMO**; hereinafter called the "ENTITY", and **TTAI GENERAL CONSTRUCTION** at Blk. 26 Lot 22 Phase 2 Carissa Homes, Tanza, Cavite called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR executes the Work – Under **Contract No. 4AC-RRC-19-005** Construction of Canal Lining of **LANTIC CANAL IRRIGATION SYSTEM in Carmona, Cavite** hereinafter called "The Works", and the ENTITY has accepted the Calculated Bid of the CONTRACTOR for the execution and completion of the Works at the stated unit bid prices shown in the attached Bill of Quantities, or a Total Contract Price of **FIVE MILLION THREE HUNDRED THIRTEEN THOUSAND NINETY-FIVE AND 82/100 PESOS ONLY (Php 5,313,095.82)**




