GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES, **NATIONAL IRRIGATION ADMINISTRATION, CAVITE-BATANGAS IMO**; hereinafter called the "ENTITY", and **NB AVILA CONSTRUCTION** at # 3 Bucal 3-B, Maragondon, Cavite called the "CONTRACTOR".






