"CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR executes the Work – Under
Contract No. 4AC-RRN-19-015 Construction of Canal Lining of **SAHING RIVER
IRRIGATION SYSTEM in Naic, Cavite** hereinafter called "The Works", and the
ENTITY has accepted the Calculated Bid of the CONTRACTOR for the execution and




