GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES, **NATIONAL IRRIGATION ADMINISTRATION, CAVITE-BATANGAS IMO**; hereinafter called the "ENTITY", and **NB AVILA CONSTRUCTION** at # 3 Bucal 3-B, Maragondon, Cavite called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR executes the Work – Under **Contract No. 4AC-RRN-19-025** Construction of Canal Lining of **KAY-AKLE (CANTARICIO) RIVER IRRIGATION SYSTEM in Naic, Cavite** hereinafter called "The Works", and the ENTITY has accepted the Calculated Bid of the CONTRACTOR for the execution and completion of the Works at the stated unit bid prices shown in the attached Bill of Quantities, or a Total Contract Price of **THREE MILLION SIX HUNDRED EIGHTY-ONE THOUSAND TWO HUNDRED TWENTY-NINE AND 35/100 PESOS ONLY (Php 3,681,229.35)**
