WHEREAS, the ENTITY is desirous that the CONTRACTOR executes the Work – Under **Contract No. 4AC-EGP-19-056** Drilling Works and Construction of Solar Pump Facilities of **LUMIPA PUMP IRRIGATION PROJECT in Gen. 


