called the "ENTITY", and KGB ENGINEERING AND CONSTRUCTION at Brgy.
Poblacion II, Santa Cruz, Occidental Mindoro called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR executes the Work –
Under Contract No. 4AC-FS-23-009 Feasibility Study - Drilling and Installation of
Well Casing and Resistivity Test of KAYMISAS PUMP IRRIGATION PROJECT
in Gen. Emilio Aguinaldo, Cavite hereinafter called "The Works", and the ENTITY has
