called the "ENTITY", and R2A CONSTRUCTION AND TRADING at 09 Pag-asa I,
Imus, Cavite called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR executes the Work –
Under Contract No. 4AC-RRN-23-012 Construction of Canal Lining at Sta.
0+188.00 - 0+649.25 Lat C-3 of SAN AGUSTIN River Irrigation System in Imus,
Cavite hereinafter called "The Works", and the ENTITY has accepted the Calculated
