GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES, **NATIONAL IRRIGATION ADMINISTRATION, QUEZON IRRIGATION MANAGEMENT OFFICE**, LUCENA CITY, QUEZON ;hereinafter called the "ENTITY", and **KKT CONSTRUCTION AND SUPPLY** at Lot 31 Block 3 Alpsville 3 Subd., Iba. Dupay, Lucena City , Quezon called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Work - Under **Contract No.4AQ-RRC-19-001** for the Construction of Canal Lining of **MANGGALANG BIRHENAN COMMUNAL IRRIGATION SYSTEM** in Sariaya, Quezon hereinafter called " The Works", and the ENTITY has accepted the Calculated Bid of the CONTRACTOR for the execution and completion of the Works at the stated unit bid prices shown in the attached Bill of Quantities, or a Total Contract Price of **ONE MILLION EIGHT HUNDRED SIXTY THOUSAND FOUR HUNDRED SEVENTEEN PESOS & 4/100 (Php1,860,417.04)**.


