THIS CONTRACT AGREEMENT, made this 19th day of December, 2022 between GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES, NATIONAL IRRIGATION ADMINISTRATION - QUEZON IRRIGATION MANAGEMENT OFFICE, Lucena City, Quezon hereinafter called the "Entity" and M.C. REFAZO BUILDERS at Dahlia St. Villa Aurea Subdivision, Brgy. Domoit, Lucena City, Quezon hereinafter called the "Contractor".

WHEREAS, the Entity invited Bids for **Job Order: Furnishing labor, materials, equipment and tools for the Proposed Canal Lining of Manggalang Birhenan CIS at Sariaya, Quezon under GAA Fund CY 2018** hereinafter called "the Works" and the Entity has accepted a Bid in the sum of **One Hundred Sixty Thousand Six Hundred Eighty Pesos & 27/100 (Php 160,680.27)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:

- a. Philippine Bidding Documents (PBDs);
  - i. Drawings/Plans;
  - ii. Specifications;
  - iii. Bill of Quantities;
  - iv. General and Special Conditions of Contract;
  - v. Supplemental or Bid Bulletins, if any;
- b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted, including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

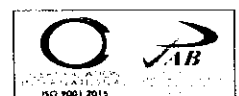

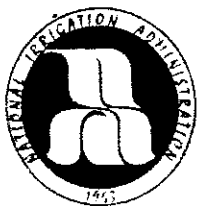

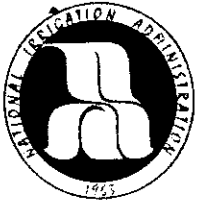
