THIS **CONTRACT AGREEMENT**, made this 3rd day of July, 2019, GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES, **NATIONAL IRRIGATION ADMINISTRATION**, REGION IV-A, PILA, LAGUNA; hereinafter called the "**ENTITY**", and **CAANA CONSTRUCTION CORPORATION** at No. 6546 J. de Leon St., Gatchalian Village I, Paranaque City called the "**CONTRACTOR**".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Work - Under **Contract No. 4AQ-RRN-19-004** for the Construction of Canal Structures of **AGOS RIVER IRRIGATION SYSTEM PACKAGE 4** in Infanta, Quezon hereinafter called "The Works", and the ENTITY has accepted the Calculated Bid of the CONTRACTOR for the execution and completion of the Works at the stated unit bid prices shown in the attached Bill of Quantities, or a Total Contract Price of **EIGHTEEN MILLION TWO HUNDRED FIVE THOUSAND EIGHT HUNDRED TWELVE PESOS & 09/100 (Php18,205,812.09)**.
