THIS CONTRACT AGREEMENT, made this 1st day of July, 2019, GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES, NATIONAL IRRIGATION ADMINISTRATION, REGION IV-A, PILA, LAGUNA; hereinafter called the "ENTITY", and ARDA Construction and Supply at No. 8888 1st Street, Phase II, Pleasantville Subdivision, Iyam, Lucena City called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Work - Under Contract No. **4AQ-RRN-19-005** for the Construction of Canal Structures of **AGOS RIVER IRRIGATION SYSTEM- PACKAGE 5** located in Infanta, Quezon hereinafter called "The Works", and the ENTITY has accepted the Calculated Bid of the CONTRACTOR for the execution and completion of the Works at the stated unit bid prices shown in the attached Bill of Quantities, or a Total Contract Price of **THIRTEEN MILLION TWENTY FIVE THOUSAND EIGHT HUNDRED NINETY NINE PESOS & 15/100 (Php13,025,899.15)**.

NOW THIS CONTRACT AGREEMENT WITNESSETH AS FOLLOWS:


1. In this **CONTRACT AGREEMENT**, words and expressions shall have meanings as are respectively assigned to them in the Conditions of hereinafter referred to.






