THIS **CONTRACT AGREEMENT**, made this 5<sup>th</sup> day of July, 2019, GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES, **NATIONAL IRRIGATION ADMINISTRATION**, REGION IV-A, PILA, LAGUNA; hereinafter called the "**ENTITY**", and **P.Y. LACORTE BUILDERS** at Lot 3, Blk. 4, Villa San Miguel Subdivision, Brgy. Wakas, Tayabas City called the "**CONTRACTOR**".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Work - Under **Contract No. 4AQ-RRN-19-063** for the Construction of Service Road of **AGOS RIVER IRRIGATION SYSTEM PACKAGE 6** in Infanta, Quezon hereinafter called "The Works", and the ENTITY has accepted the Calculated Bid of the CONTRACTOR for the execution and completion of the Works at the stated unit bid prices shown in the attached Bill of Quantities, or a Total Contract Price of **NINETEEN MILLION NINE HUNDRED FIFTY FOUR THOUSAND SIX HUNDRED SEVENTY FIVE PESOS & 96/100 (Php19,954,675.96)**.






