
THIS **CONTRACT AGREEMENT**, made this 5th day of July, 2019, GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES, NATIONAL IRRIGATION ADMINISTRATION, REGION IV-A, PILA, LAGUNA; hereinafter called the "ENTITY", and **NUEDA BUILDERS CONSTRUCTION SUPPLY, INC.** at P. Cruz, Brgy. Mangino, Gapan City, Nueva Ecija called the "CONTRACTOR".


WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Work - Under **Contract No. 4AQ-RRN-19-007** for the Construction of Canal Structures of **LAGNAS RIVER IRRIGATION SYSTEM** in Tiaong, Quezon hereinafter called "The Works", and the ENTITY has accepted the Calculated Bid of the CONTRACTOR for the execution and completion of the Works at the stated unit bid prices shown in the attached Bill of Quantities, or a Total Contract Price of **TWENTY SEVEN MILLION NINE HUNDRED TWENTY THREE THOUSAND ONE HUNDRED NINETY SEVEN PESOS & 17/100. (Php27,923,197.17)**.

NOW THIS CONTRACT AGREEMENT WITNESSETH AS FOLLOWS:


1. In this **CONTRACT AGREEMENT**, words and expressions shall have meanings as are respectively assigned to them in the Conditions of hereinafter referred to.






