THIS **CONTRACT AGREEMENT**, made this 15<sup>th</sup> day of July, 2019, **GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES, NATIONAL IRRIGATION ADMINISTRATION**, REGION IV-A, PILA, LAGUNA; hereinafter called the "**ENTITY**", and **JAMVAZ BUILDERS AND SUPPLY** at D6 RBNI Bldg., Princeton St., Concepcion Pequena, Naga City called the "**CONTRACTOR**".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Work - Under **Contract No. 4AQ-ISR-19-009** for the Construction of Service Road of **LAGNAS RIVER IRRIGATION SYSTEM** in Tiaong, Quezon hereinafter called "The Works", and the ENTITY has accepted the Calculated Bid of the CONTRACTOR for the execution and completion of the Works at the stated unit bid prices shown in the attached Bill of Quantities, or a Total Contract Price of **FOUR MILLION SEVEN HUNDRED FIFTEEN THOUSAND THIRTY PESOS & 05/100. (Php4,715,030.05)**.
