and **MECHANICS CONS. CORP.** at L-6, PCS 474, Forbes St., Hobart Village,
Brgy. Kaligayahan, Novaliches, Quezon City called the "**CONTRACTOR**".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Work - Under
Contract No. 4AL-RRN-19-022B for the Construction of Protection Works of **BALANAC RIVER
IRRIGATION SYSTEM - PACKAGE 2** in Magdalena, Laguna hereinafter called "The Works",


