THIS **CONTRACT AGREEMENT**, made this 5th day of July, 2019, GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES, **NATIONAL IRRIGATION ADMINISTRATION**, REGION IV-A, PILA, LAGUNA; hereinafter called the "ENTITY", and **CHARMELDAY CONSTRUCTION SUPPLY & SERVICES** at Blk. 12, Lot 4, Grand Riviera Subdivision, Bulilan Sur, Pila, Laguna called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Work - Under **Contract No. 4AL-RRN-19-022E** for the Construction of Canal SYSTEM of **BALANAC RIVER IRRIGATION SYSTEM - PACKAGE 5** in Sta. Cruz, Laguna hereinafter called "The Works", and the ENTITY has accepted the Calculated Bid of the CONTRACTOR for the execution and completion of the Works at the stated unit bid prices shown in the attached Bill of Quantities, or a Total Contract Price of **TWENTY ONE MILLION EIGHT THOUSAND TWO HUNDRED FOUR PESOS & 69/100 (Php21,008,204.69)**.

The CONTRACTOR agrees to perform faithfully all of the Contract Works in accordance with the terms and conditions indicated hereto in the **CONTRACT AGREEMENT**, General Conditions, Instruction to Bidders, Plans and Technical Specifications and to furnish all of the equipments, materials, supplies, labor and superintendence and other facilities requisite for or incidental to the successful completion of the works and the carrying out of all the duties and obligations imposed by the **CONTRACT AGREEMENT**.





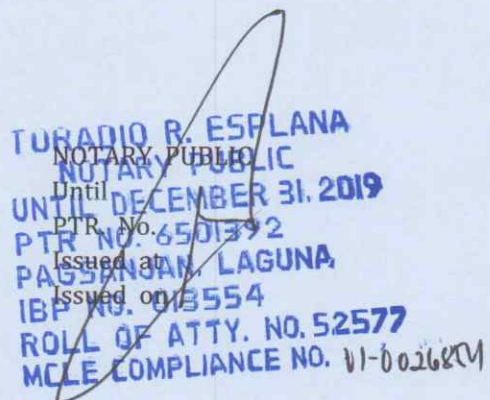
