THIS **CONTRACT AGREEMENT**, made this 16<sup>th</sup> day of August, 2019, GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES, **NATIONAL IRRIGATION ADMINISTRATION**, REGION IV-A, PILA, LAGUNA; hereinafter called the "ENTITY", and **R'CEL GEN. CONTRACTOR AND GEN. MERCHANDISE** at No. 1736 Bonifacio St., Sta. Cruz, Laguna called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Work - Under **Contract No. 4AL-RRN-19-014B** for the Construction of River Protection Works of **STA. CRUZ RIVER IRRIGATION SYSTEM - PACKAGE 2** in Liliw, Laguna hereinafter called "The Works", and the ENTITY has accepted the Calculated Bid of the CONTRACTOR for the execution and completion of the Works at the stated unit bid prices shown in the attached Bill of Quantities, or a Total Contract Price of **TWENTY EIGHT MILLION NINE HUNDRED SIXTY FOUR THOUSAND SEVEN HUNDRED SIXTEEN PESOS & 78/100 (Php28,964,716.78)**.


