THIS CONTRACT AGREEMENT, made this 15<sup>th</sup> day of August, 2016, GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES, NATIONAL IRRIGATION ADMINISTRATION, REGION IV-A, PILA, LAGUNA; hereinafter called the "ENTITY", and N.B. AVILA CONSTRUCTION at No. 3, Bucal 3, Maragondon, Cavite called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Work - Under Contract No. PLUCENA BAYAN-4M-RRENIS-CY16 - Construction of Diversion Works of PLUCENA BAYAN RIVER IRRIGATION SYSTEM, Gen.
