THIS CONTRACT AGREEMENT, made this 27th day of April, 2016, GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES, NATIONAL IRRIGATION ADMINISTRATION, REGION IV-A, PILA, LAGUNA; hereinafter called the "ENTITY", and NEW RICH GENERAL CONTRACTOR SERVICES & TRADING CO., INC. at Brgy. Sta. Ana, San Pablo City, Laguna called the "CONTRACTOR".
