THIS CONTRACT AGREEMENT, made this 21st day of October, 2016, GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES, NATIONAL IRRIGATION ADMINISTRATION, REGION IV-A, PILA, LAGUNA; hereinafter called the "ENTITY", and CHRISTIAN LEY CONSTRUCTION at Rno. 20 Burgos St. Brgy. Uno(Pob.), Cabuyao, Laguna, called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Work - Under Contract No. PALICO-10M-EEIS/NIS-CY16 - Construction of Canal System of PALICO RIVER IRRIGATION SYSTEM located in Nasugbu, Batangas hereinafter called " The Works", and the ENTITY has accepted the Calculated Bid of the CONTRACTOR for the execution and completion of the Works at the Calculated Bid of the stated unit bid prices shown in the attached Bill of Quantities, or a Total Contract Price of SIX MILLION SEVEN HUNDRED THIRTY EIGHT THOUSAND SEVEN HUNDRED THIRTY PESOS & 17/100 (Php6,738,730.17)


