THIS CONTRACT AGREEMENT, made this 7th day of July, 2016, GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES, NATIONAL IRRIGATION ADMINISTRATION, REGION IV-A, PILA, LAGUNA; hereinafter called the "ENTITY", and R'CEL GENERAL CONTRACTOR & GEN. MERCHANDISE at No. 1736 Bonifacio St. Sta. Cruz, Laguna called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Work - Under **Contract No. TALA-3M-RRECIS-CY16** - Construction of Concrete Canal Lining of **TALA COMMUNAL IRRIGATION SYSTEM**, Rizal, Laguna hereinafter called "The Works", and the ENTITY has accepted the Calculated Bid of the CONTRACTOR for the execution and completion of the Works at the stated unit bid prices shown in the attached Bill of Quantities, or a Total Contract Price of **TWO MILLION SEVEN HUNDRED SEVENTY THREE THOUSAND SEVEN HUNDRED THIRTEEN PESOS & 63/100 (Php2,773,713.63)**






