THIS CONTRACT AGREEMENT, made this 18th day of July, 2016, GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES, NATIONAL IRRIGATION ADMINISTRATION, REGION IV-A, PILA, LAGUNA; hereinafter called the "ENTITY", and CHARLMELDAY CONSTRUCTION SUPPLY & SERVICES at Blk. 12, Lot 4, Grand Riviera Subdivision, Pila, Laguna called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Work - Under Contract No. PALAYAN-2M-RRECIS-CY16 - Construction of Canal System for PALAYAN COMMUNAL IRRIGATION SYSTEM, Nagcarlan, Laguna hereinafter called "The Works", and the ENTITY has accepted the Calculated Bid of the CONTRACTOR for the execution and completion of the Works at the stated unit bid prices shown in the attached Bill of Quantities, or a Total Contract Price of ONE MILLION EIGHT HUNDRED NINETY FOUR THOUSAND SIX HUNDRED FIFTY FIVE PESOS & 81/100 (Php1,894,655.81)


