
THIS CONTRACT AGREEMENT, made this 25th day of April, 2016, GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES, NATIONAL IRRIGATION ADMINISTRATION, REGION IV-A, PILA, LAGUNA; hereinafter called the "ENTITY", and K.I. ENGINEERS TECHNICAL CONSTRUCTION & TRADING at No, 737 Poblacion, Noveleta, Cavite called the "CONTRACTOR".


WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Work - Under Contract No. **MAGAY-3M-RRECIS-CY16** - Construction of Canal System of **MAGAY COMMUNAL IRRIGATION SYSTEM**, Maragondon, Cavite hereinafter called "The Works", and the ENTITY has accepted the Calculated Bid of the CONTRACTOR for the execution and completion of the Works at the stated unit bid prices shown in the attached Bill of Quantities, or a Total Contract Price of **TWO MILLION SEVEN HUNDRED FORTY SIX THOUSAND SEVEN HUNDRED NINETY ONE PESOS & 69/100 (Php2,746,791.69)**.


