THIS CONTRACT AGREEMENT, made this 18th day of July, 2016, GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES, NATIONAL IRRIGATION ADMINISTRATION, REGION IV-A, PILA, LAGUNA; hereinafter called the "ENTITY", and JEFF ENTERPRISES No. 66 A. dela Cruz St., San Diego Zone I, Poblacion, Tayabas City called the "CONTRACTOR".




