THIS CONTRACT AGREEMENT, made this 5th day of April, 2016, GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES, NATIONAL IRRIGATION ADMINISTRATION, REGION IV-A, PILA, LAGUNA; hereinafter called the "ENTITY", and JOERG BUILDERS at No. 253 Quezon Avenue Extension, Lucena City called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Work - Under **Contract No. PHINGA NORTE-8M-RRECIS-CY16** - Restoration of Diversion Works of **PAHINGA NORTE COMMUNAL IRRIGATION SYSTEM**, Candelaria, Quezon hereinafter called "The Works", and the ENTITY has accepted the Calculated Bid of the CONTRACTOR for the execution and completion of the Works at the stated unit bid prices shown in the attached Bill of Quantities, or a Total Contract Price of **SEVEN MILLION TWO HUNDRED FIFTY EIGHT THOUSAND TWO HUNDRED FIFTY SIX PESOS & 37/100 (Php7,258,256.37)**


