THIS CONTRACT AGREEMENT, made this 15th day of April, 2016, GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES, NATIONAL IRRIGATION ADMINISTRATION, REGION IV-A, PILA, LAGUNA; hereinafter called the "ENTITY", and JAIME B. CHING ENTERPRISES at No. 28 Calihan St, Brgy. San Francisco, San Pablo City, Laguna called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Work - Under Contract No. STA CRUZ-2.5M-NIS EXTN-CY16 - Construction of Canal System of STA. NOW THIS CONTRACT AGREEMENT WITNESSETH AS FOLLOWS:


1. In this CONTRACT AGREEMENT, words and expressions shall have meanings as are respectively assigned to them in the Conditions of hereinafter referred to.






