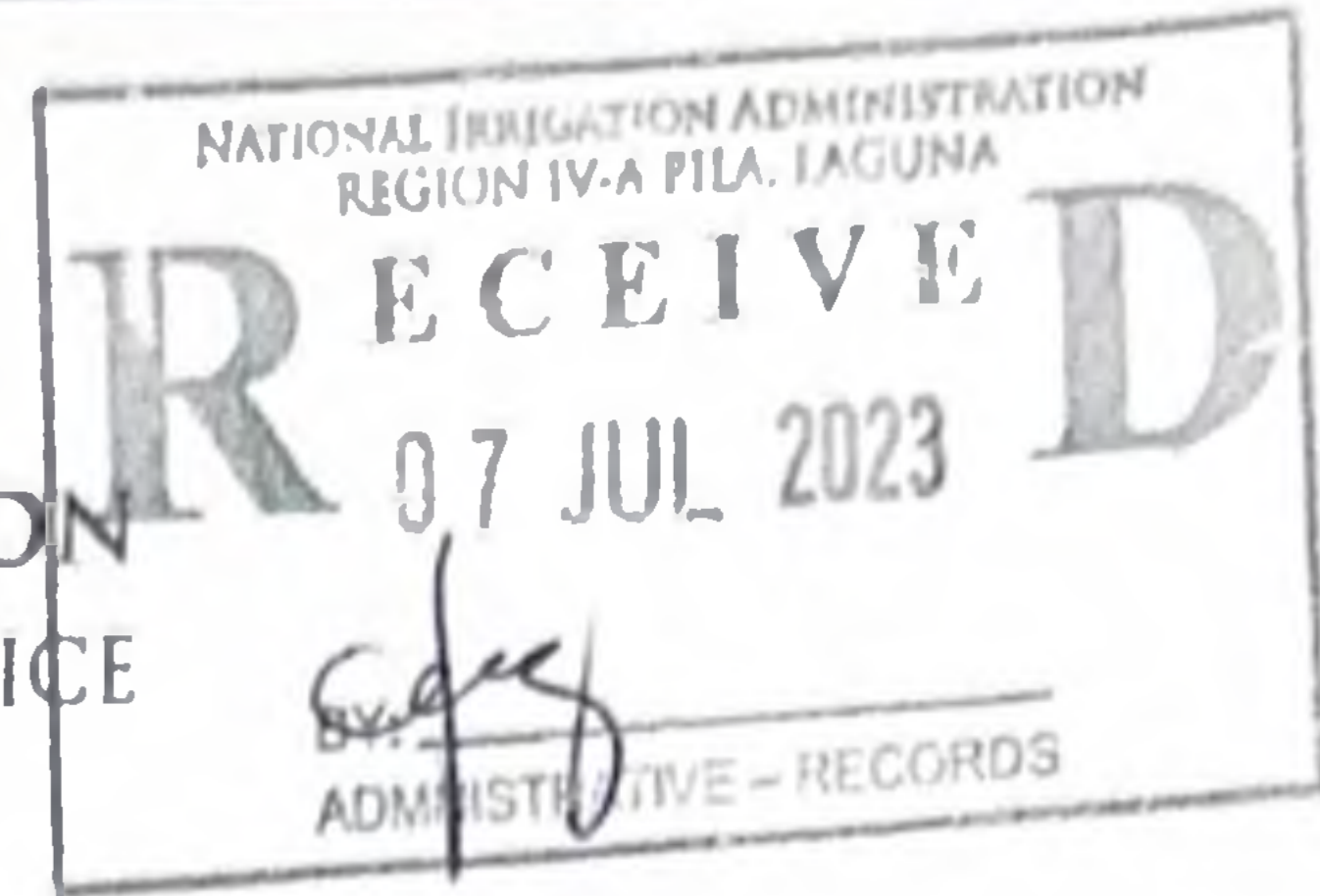

**Invitation to Re-Bid for the Construction of Concrete Canal Lining of
Macabling River Irrigation System**
Sta. Rosa City, Laguna

1. The NIA LRIMO Office, through the *GAA CY 2023* intends to apply the sum of *Four Million Seven Hundred Forty Thousand Five Hundred Ninety-Two Pesos and 30/100 (P4,740,592.30)* being the Approved Budget for the Contract (ABC) to payment under the contract for the *Construction of Concrete Canal Lining of Macabling River Irrigation System* with Project Identification No. *4AL-RPN-23-027*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The NIA LRIMO now invites bids for the above Procurement Project. Completion of the Works is required within *120 calendar days*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders). *Minimum equipment requirement/s:*

1 (One) Unit 1-Bagger Concrete Mixer
3. Onetime group site inspection is scheduled on *July 11, 2023, Tuesday, 9:00 AM*. The meeting place will be at *NIA LRIMO Office, Pila, Laguna* at *8:30 AM*. Site inspection is necessary in coming up of a responsive bid.
4. Bidding will be conducted through open competitive bidding procedures using nondiscretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
5. Interested bidders may obtain further information from the *Secretariat, Bids and Awards Committee, NIA LRIMO Office, Pila, Laguna* and inspect the Bidding Documents at the address given below from *8:00 AM to 5:00 PM, Monday to Friday*.
6. A complete set of Bidding Documents may be acquired by interested bidders on *July 7, 2023* from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB upon presentation of *Letter of Intent (LOI), PhilGEPS Registration, renewed PCAB License with "Small B" in Irrigation and Flood Control-IAC Certificate of Registration, renewed & valid Mayor's/Business Permit, Tax Clearance, DTI Registration Certificate or SEC Registration Certificate and Certificate of Site Inspection issued by the Laguna-Rizal IMO Manager*, at the NIA LRIMO Cashier of a non-refundable fee in the amount of *Five Thousand Pesos (P5,000.00)* The Procuring Entity shall allow the bidder to present its proof of payment for the fees through facsimile.
7. The NIA LRIMO will hold a *Pre-Bid Conference on July 14, 2023, Friday, 10:00 AM* at the *NIA LRIMO Conference Room, 2nd Floor NIA LRIMO Office, Pila, Laguna* which shall be open to prospective bidders.
8. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below *on or before 10:00 AM on July 27, 2023, Thursday*. Late bids shall not be accepted.
9. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the ITB Clause 16.
10. Bid opening shall be on *10:01 AM on July 27, 2023, Thursday* at the given address below. Bids will be opened in the presence of the in the presence of the bidders' representatives who choose to attend the activity
11. The National Irrigation Administration Laguna-Rizal Irrigation Management Office (LRIMO) reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time
