



**Invitation to Bid for Procurement, Delivery &
Installation of 10" Ø x 6m HDPE Pipe (SDR 21) of
Calawis Small Irrigation Project**

1. The NIA LRIMO Office, through the *GAA CY 2019 & 2020 (Excess Various Funds)* intends to apply the sum of **Three Hundred Ninety Eight Thousand One Hundred Eighty Three Pesos and 64/100 (₱398,183.64)** being the Approved Budget for the Contract (ABC) to payment under the contract for **Procurement, Delivery & Installation of 10" Ø x 6m HDPE Pipe (SDR 21) of Calawis Small Irrigation Project** with contract no. **4AR-EVF-20-038**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The NIA LRIMO now invites bids for the above Procurement Project. Completion of the Works is required within **30 calendar days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders). *Minimum equipment requirement/s:*

1 (One) Unit Butt-Fusion Machine

3. Onetime group site inspection is scheduled on **January 29, 2021, Friday, 9:00 AM**. The meeting place will be at **NIA Baras Satellite Office, Baras, Rizal** at **8:30 AM**. Site inspection is necessary in coming up of a responsive bid.
4. Bidding will be conducted through open competitive bidding procedures using nondiscretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

A complete set of Bidding Documents may be acquired by interested bidders on **February 02, 2021** from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB upon presentation of **Letter of Intent (LOI), PhilGEPS Registration, renewed PCAB License with "Small B" in Irrigation and Flood Control-IAC Certificate of Registration, renewed & valid Mayor's/Business Permit, Tax Clearance, DTI Registration Certificate or SEC Registration Certificate and Certificate of Site Inspection issued by the Laguna-Rizal IMO Manager**, at the NIA LRIMO Cashier of a non-refundable fee in the amount of **Five Hundred Pesos (₱ 500.00)** The Procuring Entity shall allow the bidder to present its proof of payment for the fees through facsimile.
7. The NIA LRIMO will hold a **Pre-Bid Conference on February 02, 2021, Tuesday, 10:00 AM** at the **NIA LRIMO Conference Room, Pila, Laguna** which shall be open to prospective bidders.
