## Invitation to Bid for CALAMIGAN Small Irrigation Project

1. The **NATIONAL IRRIGATION ADMINISTRATION REGION IV-A (CALABARZON)**, through the **GAA 2021** intends to apply the sum of **Eighteen Million Nine Hundred Fifty-Two Thousand Four Hundred Eighty-Two Pesos and 33/100 (P 18,952,482.33)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Procurement, Delivery and Installation of 20 HP Solar Surface Pump and Construction of Canal Lining and Canal Structures of Calamigan Small Irrigation Project** located in **Tiaong, Quezon** with Project Identification No. **4ARO-SIP-21-002**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **NATIONAL IRRIGATION ADMINISTRATION REGION IV-A (CALABARZON)** now invites bids for the above Procurement Project. Completion of the Works is required **210 calendar days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from **NATIONAL IRRIGATION ADMINISTRATION REGION IV-A (CALABARZON)** and inspect the Bidding Documents at the address given below from **8:00 A.M** up to **5:00 P.M.**

A complete set of Bidding Documents may be acquired by interested bidders on **February 9, 2021** from given address and websites below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Twenty-Five Thousand Pesos (P 25,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees presented in person, by facsimile, or through electronic means.
6. The **NATIONAL IRRIGATION ADMINISTRATION REGION IV-A (CALABARZON)** will hold a Pre-Bid Conference on **Tuesday, February 16, 2021, 2:00 PM** at NIA Region IV-A Conference Room, 2<sup>nd</sup> Floor NIA Region IV-A (CALABARZON), Pila, Laguna which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below **on or before Tuesday, March 02, 2021, 2:30 PM**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 15.
9. Bid opening shall be on **Tuesday, March 02, 2021, 2:31 PM** at the given address below. Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity.
