**REQUEST FOR EXPRESSION OF INTEREST FOR  
PARCELLARY SURVEY QUIPOT IRRIGATION PROJECT CY2017**

1. The NIA-Quezon Irrigation Management Office through **GAA CY 2017** intends to apply the sum of **ONE MILLION FIVE HUNDRED THOUSAND PESOS (P 1,500,000.00)** being the Approved Budget for the Contract (ABC) to payments under Contract No. **4AQ-LPQ-17-01**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The NIA-Quezon Irrigation Management Office now calls for the submission of eligibility documents for the conduct Parcellary Survey for Quipot Irrigation Project. The project is located at Tiaong, San Antonio, Candelaria and Sariaya, Quezon, Rosario and San Juan, Batangas. Completion of Works is requires within **120 calendar days**. Interested consultants must submit their eligibility documents on or before **September 30, 2020** at NIA Quezon Irrigation Management Office, Lucena City, Quezon. Application for eligibility will be evaluated based on a non-discretionary "pass/fail" criterion.
3. The BAC shall draw up the short list of consultants from those who have submitted Eligibility Documents/Expression of Interest and have been determined as eligible in accordance with the provisions of the Revised Implementing Rules and Regulations of Republic Act No. 9184 (IRR 9184) otherwise known as the "Government Procurement Reform Act". The shortlist shall consist of three (3) prospective bidders who will be entitled to submit bids. The criteria and rating system for shortlisting are: Quality-Cost Based Evaluation/Selection (DCBE/QCBS) procedure.
4. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Revised Implementing Rules and Regulations of Republic Act No. 9184 (IRR 9184) otherwise known as the "Government Procurement Reform Act".
5. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
6. The NIA Quezon IMO through the BAC shall evaluate bids using the Quality-Cost Based Evaluation/Selection (DCBE/QCBS). The NIA Quezon IMO shall indicate the weights to be allocated for the Technical and Financial proposals. The criteria and rating system for the evaluation of bids shall be provided in the Instruction to Bidders.
7. Shortlisted consultants/bidders shall be notified on **October 2, 2020**. A complete set of Bidding Documents may be obtained by shortlisted consultants upon payment at the NIA Quezon IMO Cashier of a non-refundable fee in the amount of **Five Thousand Pesos (P 5,000.00)**.

8. The NIA Quezon IMO will hold a **Pre-Bid Conference on October 5, 2019, Monday, 2:00 PM** at the **NIA Quezon IMO Bids and Awards Room, Lucena City, Quezon** that will be open only to shortlisted consultants.
9. Bids must be delivered **on or before 2:00 PM, October 19, 2020**. Opening of bids will be held at the same day at **2:01 PM** in the presence of invited observers, bidders, or its duly authorized representative who choose to attend at the **NIA Quezon IMO Bids and Awards Room, Lucena City, Quezon**. Late bids shall not be accepted.
10. The National Irrigation Administration Quezon Irrigation Management Office (NIA) reserves the right to accept or reject any and all bids, to annul the bidding process and to reject all bids at any time prior to contract award, without incurring any liability to the affected bidder or bidders; and not to award the contract due to the situations cited in Section 41 of the revised IRR of RA 9184.
