



**REQUEST FOR EXPRESSION OF INTEREST FOR
 FORMULATION OF MANAGEMENT PLAN FOR IRRIGATION WATER
 RESOURCES (MPIWR) OF PALICO RIVER IRRIGATION SYSTEM**

1. The NATIONAL IRRIGATION ADMINISTRATION REGION IV-A (CALABARZON), through the GAA 2022 intends to apply the sum of **TWO MILLION FOUR HUNDRED SIXTY-EIGHT THOUSAND FOUR HUNDRED THIRTY-SIX PESOS AND 00/100 (₱ 2,468,436.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for *Formulation of Management Plan for Irrigation Water Resources (MPIWR) of Palico River Irrigation System (RIS)* located at *Nasugbu, Lian & Tuy, Batangas* under *Project Identification No. 4ARO-CCN-22-059*. Bids received in excess of the ABC shall be automatically rejected at the opening of the financial proposals.
2. The NATIONAL IRRIGATION ADMINISTRATION REGION IV-A (CALABARZON) now calls for the submission of eligibility documents for *formulation of Management Plan for Irrigation Water Resources (MPIWR) for Palico River Irrigation System (RIS)*. Eligibility documents of interested consultants must be duly received by the BAC Secretariat **on or before May 24, 2022, 2:00 PM** at NIA Regional Office BAC Conference Room, 2nd Floor, NIA Region IV-A (CALABARZON), Pila, Laguna. Applications for eligibility will be evaluated based on a non-discretionary “pass / fail” criterion.
3. Interested bidders may obtain further information from NATIONAL IRRIGATION ADMINISTRATION REGION IV-A (CALABARZON) and inspect the Bidding Documents at the address given below during 8:00 AM up to 5:00 PM except during declared holidays and weekends.
4. A complete set of Bidding Documents may be acquired by interested bidders on **May 16, 2022 to June 08, 2022, 2:30 PM** from the address below and upon payment of the applicable fee for the bidding documents, pursuant to the latest guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (₱ 5,000.00)**.
5. The BAC shall draw up the short list of consultants from those who have submitted Expression of Interest, including the eligibility documents, and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”, and its implementing Rules and Regulations (IRR). The short list shall consist of three (3) prospective bidders who will be entitled to submit bids. The criteria and rating system for short listing are:

Approach and Methodology of Proposal	50%
Qualification and Experience of Personnel	30%

6. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass / fail” criterion as specified in the IRR of RA 9184. Bidding is restricted to Filipino citizens / sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
7. The Procuring Entity shall evaluate bids using **Quality-Cost Based Evaluation / Selection (QCBE/QCBS)** procedure. The weight of technical and financial proposal shall be **80%** and **20%** respectively. The criteria and rating system for the evaluation of bids shall be provided in the Instructions to Bidders.
8. The contract shall be completed within **One Hundred Eighty (180) calendar days**.
9. The NATIONAL IRRIGATION ADMINISTRATION REGION IV-A (CALABARZON) reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
