This notwithstanding, those who responded through any of the required posting shall be allowed to participate;

WHEREAS, three (3) bidders/suppliers were invited and submitted proposals, namely: Kreotech Enterprise, Amie's & EJ Lumber & Gen. Merchandise and New Line Trading.

WHEREAS, the following price quotations were received by the BAC and received as follows;






