WHEREAS, the Approved budget for Contract for the Supply and Delivery of TELEMETRY SUBSCRIPTION FOR TELEMETRY RIVER GAUGE AND RAINFALL STATION VIA SATELLITE FOR BALAYUNGAN RIS, NAIC, CAVITE for bids and awards committee is TWO HUNDRED THOUSAND PESOS (Php200,000.00)

WHEREAS, three (3) bidders/suppliers were invited and submitted proposals, namely: PHILINSTRUMENTS CORP., MCS-J88 TRADING AND GAMMA LINE ENTERPRISES.

WHEREAS, the following price quotations were received by the BAC and received as follows;


BE IT FURTHER RESOLVED, as it is hereby RESOLVED TO notify PHILINSTRUMENTS CORP. of such award.




