WHEREAS, RA 9184 Section 53.9 Annex F also stated that “that the BAC shall prepare and send the RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This notwithstanding, those who responded through any of the required posting shall be allowed to participate;

WHEREAS, in response to the said advertisement, two (2) contractor/supplier: TANZA OASIS HOTEL AND RESORT signified interest to participate in the bidding when they submitted quotation and requirements.

WHEREAS, the following price quotations were received by the BAC and received as follows;

WHEREAS, the BAC Technical Working Group (TWG) made detailed evaluation to check any computational error / corrections and compliance with the required technical specification and the mathematically calculated bid:


